RESIDENTIAL WARRANTY



Lindsay Window and Door guarantees it will repair or replace Lindsay Window and Door vinyl window products that are defective in materials or workmanship for lifetime to the original homeowner, including parts and labor; insulated glass units are covered for materials only. All Lindsay Window and Door products shall be free of defects or Lindsay Window and Door, at its sole discretion, shall repair, replace, or refund the original purchase price of the affected item. There are no warranties or implied warranties that extend beyond the description hereof. This warranty is subject to the following terms and conditions:

CONDITIONS AND TERMS OF WARRANTY

1) The Lifetime Plus Residential Warranty applies only to the original registered homeowner at the location where the product was originally installed, in the state of Washington, within the designated local delivery area of Lindsay Window and Door (King, Kitsap, Pierce, Snohomish, and Thurston counties.) In the event the original purchaser sells the property in which the windows or doors are installed, the coverage provided by this warranty will be extended to the new owner but limited to a period of five years from the date the registered homeowner transfers ownership.

2) Transfer of the warranty must be registered within 30 days of ownership transfer.

3) All products must be paid in full and in a timely manner in order to qualify under the conditions of the warranty. The warranty must be registered within 30 days of installation.

4) To obtain service under this warranty, contact Lindsay Window and Door. All claims must be submitted, with proof of purchase and building ownership.

5) Lindsay Window and Door warrants the product only, not installation and any consequential damages. Unless specified otherwise, Lindsay Window and Door shall not assume liability for glass breakage or damage caused by improper installation, vandalism, misuse, abuse, or acts of nature including but not limited to fire, earthquake, flood, or any catastrophic occurrence beyond the control of the manufacturer.

6) Window screen and door screen warranty coverage will be limited to a period of 30 days from product delivery.
